The Permanent Mission of Italy to the United Nations (hereinafter the "Mission") issues a call for expressions of interest to provide the supplies indicated below.

# Insurance

COI is mandatory.

### **Purpose**

This call is aimed to start a constructive dialogue with interested companies. At this stage, expressions of interest are not binding. Applicants do not qualify for preferred placement position in the adjudication process.

## Requirements

As a guarantee of sound business practices, companies must include in the expression of interest the following information:

- Business license and permits
- > Company profile
- > Letters of reference (or equivalent)

The expression of interest shall also indicate:

- Special discounts
- Online catalog (link)
- > Delivery options and lead-times; same-day delivery costs (if available)
- > Customer service and return policy
- Ordering experience (e-commerce, phone, etc.)
- ➤ Online budgets (ability by account administrators to assign budgets to users or cost centers; if a user or cost center goes over budget, prevent checkout or send a notification to the user/manager).
